Background:

On March 25th, 2010 the DNSSAB issued CHS Notice number 2010-04 which updated

the year-end reporting requirements as required by the Annual Information Return (AIR). At that time, the DNSSAB distributed revised copies of a Microsoft Excel spreadsheet developed by the Ministry of Municipal Affairs and Housing as well as a guide to completing the AIR.

The Ministry of Municipal Affairs and Housing has now updated both the AIR Template and the Guide to the AIR to correct the references to the Housing Service Act, 2011

In order to ensure consistency the DNSSAB has revised the Excel spreadsheet to eliminate any discrepancies between it and the Social Housing Management System. The output from the Ministry's Excel spreadsheet will match exactly to the output from the DNSSAB's SHMS. All other elements of the AIR reporting process remain unchanged from those circulated in CHS Notice #2010-04 including the specific information required for each program type.

Action: All Housing Programs must submit the REVISED Annual Information Return for their fiscal years ending on or after <u>December 31st 2012</u>.

Please note: An electronic copy of the "Implementation Guide To: Ontario Social Housing Annual Information Return (AIR)" and a copy of the revised AIR template named "AIR_TEMPLATE_Nov_2012.xls" will be sent via email to all Housing Providers. Please ensure that you (or your auditors) are completing the correct version. It will also be posted to the Social Housing Management System: http://housing.dnssab.on.ca DNSSAB and the web site: http://www.dnssab.on.ca/housing.

Please note that French versions of the template and the guide are still being developed by the Ministry of Municipal Affairs and Housing. As soon as they are received, they will be made available to providers.
